THIS AGREEMENT made this 17th day of January, 2019, by and between the Board of Trustees of Jackson Township, Seneca County, Ohio hereinafter called the TRUSTEES, and the Risingsun Volunteer Fire Department of Risingsun, Ohio, hereinafter called FIRE DEPARTMENT;

WITNESSETH,

WHEREAS, the FIRE DEPARTMENT has been formed and organized as a volunteer fire department for services in Jackson Township, Seneca County, Ohio and

WHEREAS, the TRUSTEES are satisfied that the organization of the FIRE DEPARTMENT is of such character as to give assurance of permanency and efficiency,

NOW THEREFORE, in consideration of their mutual promises as contained herein, the TRUSTEES and the FIRE DEPARTMENT agree to the following,

the FIRE DEPARTMENT agrees to furnish fire protection throughout the limits of Jackson Township, Seneca County, Ohio for the three (3) year term beginning January 1, 2019 through and including December 31, 2021, and in consideration for said fire protection,

the TRUSTEES agree to pay the FIRE DEPARTMENT annual payments in the sum of Seven Thousand Five Hundred and 00/100 Dollars (\$7,500.00) per year. Payments will be made on or before June 30 of each respective year.
