A RESOLUTION OF THE VILLAGE OF RISINGSUN OF THE NECESSITY TO RENEW THE 5 YEAR 2.0 MILL LEVY IN EXCESS OF THE TEN MILL LIMITATION WHICH WAS PASSED NOVEMBER 3, 2015 FOR THE GENERAL CONSTRUCTION, RECONSTRUCTION, RESURFACING, AND REPAIR OF STREETS, ROADS, AND BRIDGES WITHIN THE VILLAGE AND TO DECLARE AN EMERGENCY

WHEREAS, the Council of the Village of Risingsun has determined that the amount of monies that may be raised within the ten-mill limitation by levies on the current tax duplicate will be insufficient to meet the costs of general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges within the Village; and

WHEREAS, at the general election held on November 3, 2015, the electors of the Village of Risingsun approved a five (5) year two (2.0) mill levy in excess of the ten (10) mill limitation for the expenses of general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges within the Village; and

WHEREAS, the assessment of the monies generated by said levy were placed on the tax duplicate effective January 1, 2015 and were collected on or after January 1, 2016 and thereafter for a period of five (5) consecutive years; and

WHEREAS, the Council of the Village of Risingsun has determined that in order to meet the expenses of the general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges within the Village, it is necessary to renew said levy for an additional period of five (5) years against the real property located within the Village; and

WHEREAS, Ohio Revised Code §5705.19(G) permits the collection of such a tax for the expenses of the general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges within the Village; and

WHEREAS, the Council of the Village of Risingsun desires to submit the issue to the residents of the Village at the November 3, 2020 General Election, in compliance with RC §5705.191.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF RISINGSUN, WOOD COUNTY, OHIO, WITH TWO-THIRDS OF ITS MEMBERS CONCURRING, THAT:

SECTION 1: The issue of renewing the existing tax levy in the amount of two (2.0) mills for each one dollar of valuation for a duration of five (5) years for the purposes of meeting the expenses of the general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges within the Village under RC 5705.19(G) shall be submitted to the voters at the November 3, 2020 General Election.

**SECTION 2:** The Fiscal Officer of the Village is hereby authorized and directed to certify a copy of this resolution to the Auditor of Wood County, Ohio.

SECTION 3: The Auditor of Wood County, Ohio is hereby requested and authorized to certify to the taxing authority the total current tax valuation of the subdivision and the dollar amount of revenue that would be generated by such a levy, pursuant to RC §5705.03.

SECTION 4: This Resolution has been declared an emergency, as due to the COVID-19 declared pandemic and the restrictions placed upon public meetings by the Governor of the State of Ohio, Council does not have the time required to pass this resolution with three readings. Furthermore, lacking the funding provided by this levy is necessary to protect the health, safety, and welfare of the residents of the Village.

**SECTION 5:** All formal actions of Council relating to the adoption of this ordinance, and all deliberations of Council and any of its committees leading to such action were in meetings open to the public as required by law.
