

ORDINANCE _2021-007

AN ORDINANCE AMENDING ORDINANCE 2020-013 AS A SUPPLEMENT TO THE 2021 ANNUAL APPROPRIATIONS,
AND DECLARING AN EMERGENCY.

WHEREAS, the current year appropriation amounts within certain funds must be amended for various purposes; and
WHEREAS, available balances within these funds are available for appropriation to facilitate necessary expenses;
NOW THEREFORE, BE IT ORDAINED, by the Council of the Village of Risingsun, County of Wood, State of Ohio;

SECTION ONE

THAT, the following appropriation be increased in the General Fund:


THAT, the following appropriation be increased in the Magistrate Court Custodial Fund:

Distribution to Other Funds (Primary Government)/Other Expense (9901-883-690)	\$10,000


SECTION EIGHT
