GUESTS - Darlene Dennis, Sandy Stephenson (Risingsun Area Historical Society)

- As of February 18th 2021 Risingsun Town Hall and Opera House was listed on the National Registry of Historic Places by the United States Department of Interior.
- > 5 members of the Historical Society visited Centec Cast & Metal in Fremont that does signage for such things as Historical Locations. Seems that they are way behind on orders so the plaque would be a few months out.
- The Society plans to purchase a 20" x 24" brass plaque at the cost of \$1350.00 to be hung to west of the main door of the hall.
- The Society is accepting donations to pay for the plaque.
- Gena will look into the feasibility of the Village making a donation toward the purchase of the plaque.
- Please follow the Risingsun Area Historical Society on Facebook for updates and information on Risingsun.
- Mayor Whetsel will put information on Facebook and Village Website.
- Who will hang the sign once it is done? Mayor Whetsel to look into this.
- Mayor Whetsel expressed how proud and thankful he and the council is for all the hard work done by Darlene and her Daughter Stacey Gable to get this over the finish line.
- Darlene and Sandy stated they will be working at the museum going thru items with plans to change displays quarterly.
- Jared to see if the Fostoria Masons would be willing to donate a corner stone for the Village.

- Darlene also wanted to thank JC Gschwind, Betty Sahs, Mike Cox, Jim Cox, and Gena for their help in the process.
- Copy of the Application and Documentation will be available to view in the Historical Museum. This was a 2 part application first approved at the State and then at the National level. As of February 18th 2021 Risingsun, was put on the registry.
- Just to put into perspective the application is 28 pages long. Darlene expressed that it was harder to complete than term papers in college.

MAYORS REPORT - Rick Whetsel, Mayor

- Street and Finance Comm. needs to let the public know when their meetings are and make sure they were publicized. Minutes will need to be documented and retained.
- Mayor Whetsel expressed that he completed the "Sunshine Law" course for 2020. The course was virtual this year. All open records will be made available. There will be a cost for copies.
- Mayor Whetsel also expressed he will be completing guidelines for employees as it pertains to leave, wages etc. He also stated that he did look into laws/regulations for part time employees and it seems it is up to the employer. This document will be e-mailed to all council members and will be reviewed and voted upon.
- Record Retention plan needs to be established per audit findings.
- Would like to establish an Employee Handbook containing job descriptions etc.
- Mayor would like the council to divide and concur to get these policies and procedure together and voted on.
- Park building restrooms. The restrooms are unsafe and unsanitary and will be locked up. The Mayor will contact Bugners to have a Porta Pot delivered at a cost of around \$105.00 / mth. Looking at only having it in the park for spring and summer. Tim Woodruff replied that the park needs a restroom facility. So, the council is looking into non-match grants etc. to possibly fund a restroom facility.
- Also, at the park there will equipment and tree removal coming this summer.

 Central Park fencing needs removed. Larry Below asked that the old movie theater posts remain. Council laughed as to how long ago that would have been and Larry reminisced about watching movies with Dale Loomis and Gus Cassidy.
- Garage Sales No sign ups, will publicize at the churches. May 21, 22 will be the dates and the hours are up to the home owners.
