- O2021-008 Tax Ordinance (Estimate of Revenues) Will have to have a special meeting on July 6th to pass as an emergency. We are late due to Auditors.
- O2021-009 Allowing Fiscal Officer 3 days to deposit.
- 4 Council seats available this fall at the ballot box. If interested the information needs to be to the Board of Elections by August 4th (90 days prior to election). The 4 seats available are for Larry Below, Tim Woodruff (Rachal Dissaur's), Dan Conner, Linda Krotzer.
- Ball meeting was conducted earlier in the day the attendees were Mayor Whetsel, John Dierksheide, Jared Capelle, Justin Spencer, Perry Hartley. Issues were worked out and were informed of some stats for the little league: 43 kids signed up for Little League making 2 t ball teams / 1 8u boys / 1 8u girls. 41 girls signed up for the Outlaw teams.
- Received deeds to Onsel Properties. Seems they included a lot that is of no use to the village as it encompasses ¼ of one of the buildings that Gallagher still owns. Looking a giving that back. Also, looked into surveying to have better understanding of where exactly the property line is. Surveying prices are ridiculous Poggemeyer wanted \$2008.00 and Marsh and Marsh wanted 2000.00 to do one lot.
