MAYORS REPORT - Mayor Rick Whetsel

- Zoning Issue: A letter was received and brought up to Mayor Whetsel which was shared with council. Mayor Whetsel will stay on top of the issues.
- Zoning Issue: Change from a Zoning board to a Planning Comm. to allow for councilman to be on the committee. This will hope get enough people to start making changes and move forward on issues.
- Zoning Issue: Demolish burnt / blight properties. Jared C. to look into this process. It will definitely take some discussions with the property owners to acquire consent to proceed. Earl M. will discuss this matter with Mr. Gallagher as he has a property in question on Maple.

STREET COMM. - John D.

- Village dump truck experienced a flat right rear tire. Jared C., and John D. were notified and instructed the street dept to get it fixed repairs were \$392.00.
- Next week black top will be purchased and patching will begin in problem spots.
- Mower maintenance will begin next week. The dept. should have everything it needs to get them ready for the season.

ARP (American Rescue Plan) COMM. - Jared C.

- > 2 meetings under our belt and were looking into expanding the park building to allow for external restroom facilities.
- > The comm. would like to explore using funds for roads however the guidelines are pretty clear so this may not be an option.
- > The comm. has reached out to Poggemyer with no response at this time.
- With the gutters falling off the hall the focus may need to shift to the town hall building and doing some much needed repair. John D. will work with the Historical Society to see what if any guidelines we will need to follow.
- Grants will be looked into as the village can use ARP funds to match grants.
