# POLICE DEPT. - Chief Shawn Beckley.

- Low on patrolman, having a hard time finding anyone.
- > Safety check in August. Will ask for assistance from other villages.

Cook Out With A Cop is coming back hopefully in August.

- Looking into JAG grant, little hard to get however, we can use for equipment and payroll.
- Lexipol Policy Levels would like to be gold for a rolling 12 mths. Training bulletins are out at least 30 / year. State requires CPT 24 hrs – OPODA has 19 available now.
- Would like to upgrade body cams in the future.

Would also like to upgrade the security cameras.

▶ 6 police officers currently doing part time which is about 16hrs / mth. Would like to get at least 20 hrs of coverage per week.
