MAYORS REPORT – Mayor Rick Whetsel (No Report)

- > 1 Ordinance and 2 Resolutions for this meeting.
 - Special Assessment Street Lighting
 - Emergency Management Contract with the County
 - Resolution accepting the amounts and rates from the County
- Flags were ordered for the Village from Grace Alley. The request from John D. to have American made flags was successful. Found Grace Alley a Veteran owned facility in Florida who produces flags made entirely from materials and labor in the USA. They use funds generated from sales to help veterans' organizations.
- Halloween October 29th

 - (No parade in Bradner this year)
- Police Chief Beckley has requested a new police cruiser. The department has funds set aside to help in the purchase the council will discuss. Chief Beckley is thinking the cost to be in the neighborhood of \$60,000.
- Food Giveaway is going to stay on thru the end of the year and then look into a delivery service or discontinuing. Discontinuing this would mean those in need would have to visit Bradner to obtain their food.

Ryan was in to address council as he would like to fill the vacant spot left by Jared Capelle. Ryan has lived in the village for several years. He has a wife and kids and a small lawn business. He currently works for Tiffin AGPro. He is vested in seeing our village succeed.

Chuck Latta

Chuck was in from the NWWSD to ask for his nomination to the Board at the District. Chuck has been with the District for 2 ½ years and was previously the Mayor of McComb. McComb had major water issues in the past and Chuck was a key player in advancing McComb's water supply into the future. His capacity at the District would be to represent small villages.

Tom Strater

Tom unfortunately was late getting to the meeting and therefore was not allotted much time. (He actually spoke after the Fire Chief) He stated that the District was upgrading their plant to include an upgraded trash trap to keep debris out of the inlet. He also spoke about the upcoming appointments to the District board. Tom also approached council about running water lines into the village. Tom stated they are ready when we are and that there is plenty of grant opportunities to help with almost anything.

FIRE DEPARTMENT - Chief Mike Cox

> 5 new pagers were added to the department. Hope to procure 5 more by then end of the year if funds are still available.

Donation to Southwest Ambulance district was made in the form of old equipment not needed. Wayne also donated to the Southwest Ambulance, with their donation the potential to get a second ambulance up and running looks good.

Retiring the wells for the unused fire hydrants. Chief Cox reached out to the EPA. Tom from the District added that they are not ready for the grant process yet. Tom stated he would make some calls to see what if any information he could come up with. Some figures were tossed around at \$30,000 to cap all wells. Holman Drilling has capped some wells at around \$2,000. / well.

Rick asked if the Dept. was still interested in using the old bathrooms at the park for training. Mike replied yes however, he is currently working on another location for training at this time.
