MAYORS REPORT - Mayor Rick Whetsel

- Fim W. and Mayor Whetsel will get the LED lights at the park installed. They will be doing this as time permits between rentals.

- Park grant material has arrived. It is as always, the same 3 tier system of funds with the deadline of Oct. 20th. Council needs to discuss what projects need completed. Also, they did change the amount copies that need sent in for review to 7. Along, with the park grant Mayor Whetsel reached out to the sewer district to see what if anything they could do to maintain their entrance to the treatment plant.

POLICE DEPT. - Chief Shawn Beckley

- Cook Out with a Cop 12 2p July 1st Ice Cream truck, bounce house and plenty of food.
- OVI checkpoint for this year is pending getting additional resources from neighboring villages.
- Man power is an issue as with many departments. Chief Beckley stated the department is still looking for new officers.
- Chief Beckley stated he was looking at becoming a member of the Ohio Collaborate to help set standards regulations at the state level. This is made possible thru the departments achievements in becoming a Gold Member of Lexipol. The department has worked very hard to achieve the Gold status.
- The state has also added an additional 24 hours of training to the yearly continuous education the officers are currently working on getting this training achieved.
- > The department would like to upgrade Tasers, Body Cams, and Radios.
- The department is also requesting the council to seriously look at upgrading the 6 year old cruiser to a Chevy Tahoe. Chief Beckley stated that a Tahoe fully loaded and equipped would run around \$60,000. He also stated to council that there is \$13,000. In his capital funds and that the old cruiser could hopefully yield \$10,000 from resale. Mayor Whetsel asked Chief Beckley to get a date setup to discuss.

FIRE DEPT. - Chief Mike Cox.

- Waiting on information on the grant. Hoping to hear something by the first of the year.
- Railroad wash out by the fertilizer plant. Needs new culvert. Railroad is currently just adding stone. Chief Cox assured the council that the EPA, State Representatives, and the Governor have been contacted about this matter.
