## MAYORS REPORT - Mayor Rick Whetsel

- Mayor asked council to consider adding an additional stop sign to Main Street at the corner of Main and Pearl Street. There have been numerus complaints of speeding vehicles thru the area. Rick noted that we will need an ordinance 3 reads, posted for 60 days then run with 15 days as a warning period. Council agreed and the Mayor will discuss with Corey Speweik.
